Subject: 2026 ASRI Ground Station Administration (AGSA) VHF Voice Service and FCC Regulatory Fee Notification

Dear ASRI Customer:

Aviation Spectrum Resources, Inc. (ASRI) is the FCC licensee for aeronautical enroute air-ground radio frequencies, which are used to provide the Ground Station Administration (GSA) service. The ASRI Board of Directors approved an increase to the 2025 ASRI Ground Station Administration (AGSA) VHF Voice annual service fees for 2026.

The AGSA fees will increase from \$465 per frequency per year to \$485 per frequency per year. Annual customers will continue to be billed in advance, in January of each year. The following is for your comparison:

Description	2025	2026
AGSA VHF Voice Rate	\$465 per frequency per year	\$485 per frequency per year

In addition, the ASRI Board of Directors approved the following increase in one-time fees:

Year	2025	2026
Order Processing Charge	\$115 per license	\$125 per license
Temporary Authority License (while waiting on permanent license)	\$100 per frequency	\$120 per frequency

ASRI is anticipating the renewal of approximately 755 aviation ground station licenses in 2026 and will notify all Customers in advance of their upcoming renewals. ASRI is closely monitoring operating expenses and will notify Customers, accordingly, should the ASRI Board of Directors require any further rate changes.

The 2026 *renewal-only* fees, for each 10-year aviation ground station license, will be approx. \$360 (\$235 Federal Communications Commission (FCC) fees and ASRI's one-time order processing fee of \$125). The 2026 *renewal-modification* fees, for each 10-year aviation ground station license, will be approx. \$465 (which includes the \$340 Federal Communications Commission (FCC) fees and ASRI's one-time order processing fee of \$125).

Federal Communications Commission (FCC) fees are subject to change at any time by the FCC.

Please inform your finance personnel, and any others that need this information for budgeting purposes, etc. **NOTE: DO NOT PAY NOW.** You will be invoiced in January 2026 for the new rate. Please wait to pay your invoice until received.
